Fielder’s Choice cannot guarantee any space or time not listed above.

Payment: A down payment of 25% of the total is required at the time this contract is signed. The down payment will be applied to the last month of this agreement. Payment for rentals is due by the 15th of the month prior to the rental (i.e. payment for rentals in January is due December 15th). If payment is not received by the 15th, rentals will be released and sold at the discretion of Fielder's Choice.

Cancelations: Coaches may change a rental date or time, if Fielder's Choice can accommodate. However, cancelations or changes will not be made without 48 hours' notice. Any practice canceled without 48 hours' notice will not be eligible for a facility credit. Cancelations made with proper notice will be eligible to receive a facility credit for that practice to be used later. Fielder's Choice cannot guarantee the availability of our facilities outside the times and dates agreed to above.

Refunds: There are no refunds. Teams will receive a facility credit for practices that are canceled with 48 hours' notice. The facility credit is for the exact space and session length of the canceled practice. Practices that are canceled without proper notification will be not be considered for facility credits.

Rainout List: The rainout list is a list of teams that will be called first when we have a cancelation or when the weather is poor for outdoor practice. Being on the list allows the team first access to prime practice time before it's released in our system for others to rent. Teams are called in the order in which they signed up for the list.

Rules for the facilities:

- **Gum, tobacco, seeds, and alcohol are prohibited in all areas of both facilities.** Players and parents may bring water or other beverages in sealable containers. Food is prohibited in all areas of the Clubhouse.
- **Every player must have a signed waiver on file before participating in any activities at either facility.**
- Metal cleats are only allowed on the dirt mounds at Edgemoor. Metal cleats/ spikes are not allowed anywhere in the Clubhouse.
- Teams may bring speakers and play music while practicing so long as it is not a distraction to other teams or players who are also using the facility and it is not offensive (no swearing or derogatory language).
- Do not take FC buckets to other areas of the facility.
- You may not store any team or player equipment in either facility.
- Proper equipment must be worn (helmet, face guard, cup, etc.) when batters are hitting off a machine or if the team is practicing live at-bats.
- **Treat EVERYONE in the facility with respect.**
